PUBLIC NOTICE

REVIEW OF GRANTS AND DISPOSITION (TITLES) TO PUBLIC LAND

Section 14 of the National Land Commission Act mandates the Commission to, on its own motion or upon a complaint by the National or County Government, Community or an individual, review all grants and dispositions (titles) to public land to establish their propriety or legality.

Section 6 of the Act also empowers the commission to gather information and hold inquiries.

The Commission invites all interested parties to submit five (5) copies of their representations and documents at the Secretary/CEO's office, 12th Floor, Ardhi House before the hearing date. Original documents will be verified during the hearing. Where possible, complainants should serve other interested parties.
